## MACRO ECONOMIC UPDATE



### **GLOBAL**

- Concerns about the health of the global economy came to the fore in October as the IMF in its latest edition of the World Economic Outlook tagged "countering the cost-of-living crisis" cited the aggressive pace of rate hikes by global central banks, ongoing dispute between Russia and Ukraine and the lingering Covid-19 pandemic in China as headwinds to the global outlook. Specifically, IMF projects global growth to slow substantially from 6.0% in 2021 to 3.2% in 2022. In what could be regarded as good news to cheer, US headline inflation moderated for the third consecutive month to 8.2% (10 bps lower than August) in September. On the other hand, UK inflation rose by 20 bps to 10.1% y/y in September from 9.9% in August.
- In the oil market, the large and unexpected production cut of 2 million bpd instituted by OPEC+ at the start of the month helped in easing concerns about slowing demand for crude even as supply challenges persisted due to limited flow of energy products via the Nord stream pipelines. Eventually, Brent crude oil prices increased by 3.3% m/m to an average of \$93.13 (September: \$90.16).
- Developments in UK's political landscape gained widespread attention as Liz Truss made history as the shortest-serving Prime Minister in British history after she announced her resignation after six weeks in office. At the tail end of the month, King Charles appointed Rishi Sunak as the leader of the U.K. Parliament.
- Global stocks staged an impressive comeback in October, recovering some of the losses seen since July when aggressive rate hikes by central banks triggered sell offs in equities. In the US, DJIA and S&P advanced by 13.95% and 8.01% month-on-month respectively. Similarly, the European markets posted gains as FTSE (+1.60% m/m) and Stoxx 600 (+4.65% m/m) rose in October. However, MSCI Emerging Markets and Frontier Markets Indices faltered, declining by 1.86% m/m while MSCI shed 3.63% m/m.

### **DOMESTIC**

- The CBN Governor, Godwin Emefiele, revealed plans by the apex bank to issue new series of banknotes for the N100, N200, N500 and N1000 denominations. We understand that existing paper notes of the denominations will cease to be legal tender from 31 January 2023. The CBN Governor noted that the aim of the policy action is to improve the currency management and by extension have greater control over demand-side induced inflationary and currency pressures.
- Headline inflation rose further by 25 basis point to 20.77% y/y in September (August 20.52%), on the back of sustained pressures across the food (+22bps) and core (+40bps) baskets. Food inflation inched higher to 23.34% YoY, due to the combined impact of security challenges in food producing regions, elevated input and associated logistics costs. Similarly, core inflation rose to 17.60% y/y due to the knock-on effects of elevated energy prices, rising commodity prices and liquidity challenges in the FX market.

# FINANCIAL MARKET UPDATE

### **EQUITIES**

- The local bourse suffered its biggest monthly loss in 2022 and the fifth consecutive month of losses in September as the All Share Index declined by 10.58% m/m while the year-to-date performance moderated to +2.63% (September YTD:+14.77%).
- The bearish performance of the market was driven largely by losses in large-caps- AIRTELAFRICA (-36.25%), DANGCEM (-10.00%), and NB (-13.53%). Sectoral performance was broadly negative as the Insurance index (-5.22%) recorded the biggest loss followed by Oil and gas (-5.10%), Consumers (-2.89%), and Banking (-1.10%) indices. The Industrials goods (+6.50%) index emerged as the lone gainer propelled by BUACEMENT (+34.62% m/m).
- During the month under review, Geregu Power, a leading power generation company was listed by introduction on the Main Board of the Exchange. A total of 2.5 billion shares were listed at a price of N100.

### **FIXED INCOME**

- The fixed income market continued to experience yield expansion driven primarily by tight financial system liquidity and higher inflation numbers, as well as increased supply of short-to-medium term instruments by corporate organizations to shore up their liquidity positions.
- At the last NTB primary market auction in October, the stop rates on the 91-day, 182-day and 364-day Bills closed higher at 6.5% (+0.01%), 8.05% (+0.55%) and 14.5% (+2.50%) respectively relative to September. The secondary market for NTB also experienced yield uptick, driven by sell pressures as market players exited positions to cover liquidity shortfalls.
- The FGN bond market remained bearish in October as the average benchmark yield widened by 108basis points given the tight liquidity and consequent sell interests across the curve. At the primary market auction held within the month, stop rates surged significantly across all tenors, as the 2037 maturity recorded the highest increase of 150basis points to close at 16%.

# **OUTLOOK**



### **GLOBAL MARKETS**

As concerns about a possible global recession remain entrenched in the minds of investors, we believe market participants will continue to pay close attention to labour market data and inflation readings to gauge the policy actions of global central banks in their quest towards suppressing high levels of inflation. In the oil market, we think the pendulum will remain skewed towards supply chain constraints offsetting concerns about recession-induced slowing global demand for crude, which should keep brent crude oil prices above a baseline estimate of \$95 in the month. Our view is underpinned by the recent production cut of 2 million barrels per day instituted by OPEC+ alongside the limited flow of energy products via the Nordstream pipelines. Although G7 nations are deliberating on imposing a fixed price-cap on Russia's sea-borne oil shipments, we think the overall impact on crude oil prices will be limited given that the price cap will be referenced to global crude oil prices. Consequently, we think it is unlikely that there would be respite in sight to the energy challenges in the Eurozone. In the US, we believe market participants will continue to focus on the evolution of labour market data vis-à-vis inflation readings to gauge the policy action of the Federal Reserve. Overall, we expect volatility to continue to permeate across financial markets albeit at a moderate level as growing prospects that inflation might have peaked in US would likely improve risk on sentiments.

### **DOMESTIC MARKETS**

### **EQUITY**

With interest rate expectations still biased to the upside, we expect market sentiments to remain weak as investors continue to rebalance their portfolios towards the FI market to take advantage of attractive returns. In addition, we think the compression in margins evident in Q3 2022 corporate earnings, particularly for consumer goods companies would further exacerbate negative sentiments. Barring any positive surprises from heavyweight large caps stocks, we see scope for the local bourse to close in the red territory this month. Furthermore, as political activities take center stage in the build-up to the general elections in February 2023, we expect growing uncertainties among investors to subdue appetite for risk assets whilst FPIs continue exhibiting cold feet towards naira assets given troika impact of FX liquidity challenges, increased political risk and elevated global FI yields.

### **FIXED INCOME**

Rates are expected to remain elevated in the fixed income market on the back of the persistently high inflation rate, and increased supply of debt instruments especially from corporate organizations looking to raise capital to support their liquidity needs. We believe that the lower maturity profile in the last few months of the year, coupled with the level of liquidity in the financial system, are likely to keep yields attractive in the fixed income market. In addition, the MPC is expected to maintain its hawkish policy stance for the rest of the year given the need to reduce inflationary pressures, and to mitigate capital flight from the economy given elevated yields in the global fixed income market.
