ave you ever considered the significant impact that technology has had on our lives? Over the course of a few decades, technology has demonstrated its remarkable ability to simplify processes and enhance our quality of life. In 2018, we extended our reach by launching an incubator program for fintech and proptech startups in Nigeria. Over the past four years, we've invested over \$2 million, and 16 start-ups have grown and succeeded with our help. Examples of start-ups we've supported include Trove a micro-investing platform that has helped Nigerians surmount challenges around access to financial securities and investments in Nigeria and the international markets. RISE is another platform that has helped Nigerians grow their wealth by connecting them with diverse global, affordable investment opportunities.

In a bid to extend our impact beyond local shores, we partnered with TechStars in 2022 to deliver the ARM Labs Lagos Techstars Accelerator – a worldclass accelerator program that supports African start-ups with access to funding, a vast network of mentors, corporate partners, and investors, to help them reach new heights of growth and success.

We firmly believe in the power of innovation and technology to drive change, and we're committed to setting ambitious goals and working with industry leaders to create a thriving ecosystem of African unicorns.

DRIVING INNOVATION AND EFFICIENCY IN THE WORLD OF WORK

s businesses strive to deliver higher levels of customer satisfaction, innovation and technology have become integral components of the new world of work. In this environment, the Human Capital Management (HCM) team has partnered with the Corporate Transformation and Information Technology Departments to drive the digitalization of key processes, ultimately improving operational efficiency.

One recent success in this endeavor has been the launch of a revised Service Desk Portal, which allows employees to log service requests to all departments, improving both turn-around time and service quality. The portal also facilitates tracking and reporting of departmental resolution rates, further enhancing service delivery.

The Job Shadowing Program

The job shadowing program was launched in Q4 2022 as part of our talent management initiatives. The program aims to give employees the opportunity to be exposed to roles that are aligned with their career aspirations, develop new skills, and grow internally. The program is another way to motivate employees, broaden their skill sets, and serve as a means to build our talent pipeline for several roles across the business.

We began the first cohort with ten (10) employees. Each of these employees was placed in different departments for three (3) months, after which a case study was given to each shadow to assess their knowledge of the objectives achieved during the job shadowing program. A feedback form was also completed by shadows and hosts, to document performance and make recommendations for improvement of the program.

MANAGEMENT TRAINEE DEVELOPMENT PROGRAM (MTDP)

ixta Africa launched its first-ever Management Trainee Development Program on November 25th, 2022. The program was designed to attract top talents across Mixta Africa's subsidiaries and provide them with unique training and career development opportunities within the real estate, project development/management, recreational, and hospitality sectors.

The 12-month rotational program is aimed at identifying and recruiting talented graduates and skilled employees who meet Mixta Africa's defined criteria. The MTDP includes an intensive four-week induction and hands-on training, job rotation across specified career paths/ specialized routes, quarterly retreats and training sessions, monthly feedback sessions with supervisors, and regular updates from the Human Capital Management team. The first month of the program started with an intensive induction and orientation session, which concluded with group presentations to management. Seven external and three internal candidates were selected and given offers to participate in the program. The trainees have now been assigned to various units and have officially started their job rotation.

The MTDP represents a significant investment in human capital by Mixta Africa, as the company seeks to attract and develop top talent in the real estate industry. The program provides a unique opportunity for trainees to gain exposure to different facets of the industry and develop a deep understanding of Mixta Africa's operations. Through this program, Mixta Africa hopes to build a pipeline of future leaders who will contribute to the company's growth and success.

When the prioritized candidate experience and talent acquisition initiatives to ensure we attracted and retained top talent. As part of these efforts, monthly surveys were conducted to gather feedback from candidates on their recruitment experience. INDUSTRY TRENDS (OUTLOOK

GLOBAL OIL MARKET EXPECTATIONS

Several factors would set the direction for oil prices in 2023 amongst which are, the levels of sanctions on Russian crude oil and the effectiveness of the G7 price cap, the re-opening of China, and the ongoing hawkish monetary stance of major central banks, which could impede growth in some economies. Our base case forecast for Brent comes in at USD90.12pb in 2023.





INFLATION

The impending full downstream deregulation, effect of the flooding, the CBN suspension of FX intervention, elevated global commodities prices as well as lingering insecurity in the food producing regions and climatic conditions are all factors that could keep inflation rate elevated in 2023. Thus, we estimate an average inflation rate of 20.61%.



FIXED INCOME OUTLOOK

Yields in 2023 will be driven by robust maturities, increased government borrowings, global and domestic monetary actions direction and election jitters. We expect yields in H1:2023 to remain at moderate levels as we expect liquidity to remain elevated. However, in H2:2023, we expect an upward trend in yields as liquidity begins to thin out in the second half of the year.

CURRENT ACCOUNT

For H1:2023, we forecast a surplus in the Current Account albeit at a tepid pace. We expect the Trade Balance to trend southwards following the decline in Q3:2022 foreign Trade Figures, an offshoot of the effect of aggressive interest rate hike on output.

CURRENCY

Rebound in economic activities would elevate demand for FX which would further dampen the prospect for the Naira, given the supply constraints. The petroleum subsidy constitutes a drag on FX reserve, given the bullish sentiment around oil prices. Although Dangote Refinery is expected to begin operation in Q2:2023, and could ease our FX spendings, it would however, lower oil receipts. Given these factors and more, we expect another devaluation in 2023. Our expectation of the Naira at the official window is NGN510/USD - NGN530/USD in 2023.

EQUITIES

We expect positive sentiments in the equities market in H1:2023. This is on the back of the expectation of largely positive corporate performance, portfolio rebalancing activities, improved liquidity and bargain-hunting activities as some tickers are already trading below market value. We do not expect the 2023 general election to negatively impact the local bourse given the dominance of domestic players.



🔊 GDP

We forecast a tepid growth for H1:2023. We expect the 2023FY GDP growth rate to print at 2.66% for the base case, 1.51% for bear and 2.95% for the Bull. Our expectation is hinged on oil production improving to 1.57MMbpd in 2023FY given current realities and oil price averaging USD90.12pb. On this note, we foresee a rebound in the oil sector and tepid growth in the non-oil sector.



BANKING

The current higher interest rates environment will help grow Interest Income in 2023 especially for the Tier 1 Banks. Furthermore, recent CBN policies (withdrawal limits) could buoy increased transaction volumes for the

banks which is positive for Fee and Commission Income. Overall, our outlook for the sector is positive.

CURRENT ACCOUNT

For H1:2023, we forecast a surplus in the Current Account albeit at a tepid pace. We expect the Trade Balance to trend southwards following the decline in Q3:2022 foreign Trade Figures, an offshoot of the effect of aggressive interest rate hike on output.


10. TELECOMMUNICATION

Despite regulatory encumbrances, the sector posted an increase in mobile subscriptions in 2022FY. We expect an increase in mobile subscriptions, improved operation of mobile money service to boost fintech revenue, and improved internet penetration amid 5G roll out in 2023. Overall, our expectation for the sector in 2023 remains bullish.

The elevated price levels amid slowing

The elevated price levels amid slowing household consumption per capita dealt a huge blow to output in 2022FY. Nonetheless, most of the players were still able to leverage strategic pricing to sustain decent performances. In 2023FY, we hold that output would continue to shrink, but that will not hold traction back from the sector, given that it portends opportunity for Alpha as we ride the overall slowdown in the economy. This development ordinarily makes for traction towards the segment as a traditionally defensive segment, thus, we envisage a positive closing for the segment.





12 INDUSTRIAL GOODS In 2022FY, the Industrial Goods sector

closed on a positive note (+14.23%). We opine that the strategic pricing ability of the major players in the space played a key role in this positive close. Also, we believe that robust government capital expenditures boosted the sector's growth. For H1:2023, we expect sustained growth in the sector following improved demand, lingering positive impacts election-induced of capital expenditure and strategic pricing. Furthermore, we expect the growth in Real Estate GDP and Construction GDP to bolster the Industrial Goods sector's growth in H1:2023.



13. OIL & GAS The upstream

The upstream players benefited from the rise in global crude oil prices despite the aggregate fall in liquids production. Top line for SEPLAT advanced through 2022 as Brent reached a year high of USD127.98 in March 2022, sustaining bullish sentiments towards the company on the Nigerian Stock Exchange.

A similar case across up stream players globally. In 2023, we forecast average brent to come in at USD90.12pb, indicating favourable levels of demand. In addition, the reopening of the Forcados pipeline and Trans-Niger terminal are expected to result in increased earnings in the year, as it could potentially lead to a ramping up liquids production. In the downstream space, we have seen cost to sales margins remain lacklustre, although there was increased activity, thereby leading to increased revenues, operational costs remain elevated. This is expected to linger well into 2023, limiting downstream players' profits. Expected increase in landing costs should also weigh on expenses, as well as high inflationary pressures in the year. Players like TOTAL, ARDOVA and CONOIL should see positive returns but constrained.

Interviewer: Can you introduce us to Sadiq Mohammed? Tell us a bit about yourself. Your childhood, education, and hobbies.

SM: I grew up in Bauchi, but I am from Gombe. I come from a big family. My mother gave birth to 7 boys and 3 girls. Every day was an adventure for us in terms of going to school or studying Islamic studies at home. Subsequently, I moved back to Gombe for my secondary education, and then came back to Bauchi for university education. I studied Industrial Chemistry, and after completing my first degree, I did my NYSC as a teacher at Army secondary school, Enugu. Following my service year in 1992, I relocated to Lagos, where I have remained for over three decades. Despite spending my entire adult life in Lagos, I am yet to learn to speak Yoruba or marry a Yoruba woman.

Interviewer: What did you want to be when you were a child, and how did that influence your career path?

SM: As a child, I was fascinated by science and the many career paths it could lead to. At that time, many people were pursuing careers in fields like medicine and engineering, which only fueled my interest further. Ultimately, I decided to study Industrial Chemistry. However, as I grew older, I realised that a first degree doesn't necessarily dictate one's career path. While it can provide a solid foundation, destiny often plays a larger role in determining where one ends up. For instance, I know of three medical doctors who are now successful caterers, despite earning their MBBS degrees.





Interviewer: What have been some of the highlights of your role as Deputy CEO of ARM?

SM: It never occurred to me that I would be in ARM for two and a half decades. I joined ARM in 1996 and this is my 27th year. What made me stay this long were the different roles I functioned in, at different points. In total, I've held around 9 or 10 different positions within the company. One of the unique aspects of working at ARM is that you're constantly being challenged to take on new and diverse responsibilities, sometimes across different

subsidiaries. This helped to keep things fresh and exciting for me, as each new role felt like a brand-new job.

Another aspect that contributed to my long tenure at ARM is the fact that it's a learning organization. No matter where you are in your career, there's always something new to learn. As a new employee, you're given meaningful work and responsibilities early on. This approach can help build character and resilience, as well as teach you how to professionally. grow

Once you've been through this baptism of fire, you become unflappable and are ready to handle whatever challenges come your way.

The third thing that sets ARM apart is its flat organizational structure. Unlike many financial services firms in Nigeria, including banks and insurance companies, ARM values the opinions of all employees, regardless of their position or level of experience. This creates a respectful and inclusive workplace where everyone's voice is heard. Overall, ARM is an organization that prioritizes learning and listening, and that's why I've been proud to call it my professional home for the past 27 years. missing out on a vast potential for growth in the Nigerian economy. In summary, I would like to see ARM expand into alternative businesses to tap into the highest potential sectors in Nigeria.

Interviewer: What are some of the most important values that guide your work, and how have they influenced your career decisions?

SM: First, hard work, followed by consistency. Consistency is important and you can see that I have stayed in a particular firm for over two decades. Additionally, continuous learning is vital in today's ever-changing world. From the past to the present, things are constantly evolving, and



one must keep up to stay ahead and succeed. Refusal to evolve has rendered some professions obsolete. In life, failure to adapt or anticipate changes can result in being left behind. Lastly, it's important to be strategic. which involves identifying what's important and giving it priority. Not everything holds the same level of significance, so it's essential to have a process of elimination to differentiate between the consequential and the inconsequential.

Often, we tend to overthink about things that don't matter. Here's a helpful tip: when something happens that upsets you, and you perceive it as significant, ask yourself a series of questions to gauge its importance. Will it matter tomorrow, next week, next month, next year, two years from now, or even five years from now? Most times, you'll realize that what seemed like a big deal won't matter in the long run. If it doesn't, then it's not worth worrying about.

For instance, two people may fight over food today at a luncheon or dinner, but by the following week, they may not even recall what they ate. This shows how we can easily get worked up over things that don't matter.

Interviewer: How do you balance the need to achieve results with maintaining strong ethical standards in your work?

SM: When it comes to ethics and integrity, there is a clear divide: you either have them or you don't. The thing about ethics and integrity is that you either stand for something or you don't. If you don't stand for anything, that's a choice, but be ready as well to live with the consequences. Also,

when you think about results, it's worth noting that success isn't always defined by being the biggest or most well-known. For example, a bank with the largest network, branches, gross earnings, and customer base may not necessarily be the best option for shareholders. Another bank might provide better returns on investment, which is ultimately more valuable to shareholders than size or prestige. It doesn't matter that they are not mentioned as the biggest or the largest or the ones with the most branches or gross earnings. In the end, a fancy brand or impressive statistics don't necessarily equate to real value.

> THE THING ABOUT ETHICS AND INTEGRITY IS THAT YOU EITHER STAND FOR SOMETHING OR YOU DON'T.

Again, I firmly believe that integrity and ethics are not just theoretical concepts but practical virtues. It's only when you find yourself in a particular situation that you can truly determine if you possess them or not. For instance, you may claim to have integrity, but when a police officer pulls you over, you may consider paying a bribe to avoid wasting time over going through the proper procedure. In a country like Nigeria, where the tide is often against ethical standards and integrity, the true test of these values lies in the situations we face. As the saying goes, you never truly know a soldier until there is a war. Integrity is not about dressing up or using sirens to oppress people on the road; it's about being willing to go to Sambisa Forest to fight against bandits. It's the situations we face that reveal our true character.

Furthermore, integrity is not something that you can have one day and lose the next; it's a continuous process. While ethics and integrity are crucial, competence is equally important and should not be overlooked.

Interviewer: Can you share a lesson or experience from your personal life that has helped shape your approach to work or leadership?

SM: I've realised that there are certain aspects of our DNA that we can't change. So, instead of focusing on improving weaknesses, it's better to concentrate on our strengths, accentuate our talents, and manage our shortcomings. For instance, I'm terrible at drawing, and instead of trying to improve that skill, I would rather focus on my natural abilities and talents. By doing so, I can push myself to the people you associate with will keep you up to date on industry news and current events. Additionally, taking a holistic approach to personal and professional development is crucial. This means setting goals for the short, medium, and long-term, and considering both the technical and soft skills required to achieve them. As individuals approach the end of their careers, they often realize that soft skills are just as vital as technical skills, or even much more.

Self-discovery is also critical. Some people are fortunate enough to learn about themselves early

Interviewer: How do you stay up to date with the latest trends and developments in your industry, and what role does ongoing learning play in your career?

in life. Knowing your personality traits, both positive and negative, can help your career journey. For example, if you're aware that you have a hot temper, you can adjust your behavior when working with a team to avoid conflict. On the other hand, if you're naturally reserved and don't talk much, but your job requires you to be more active, you may need to adjust slightly from your natural inclination, to be effective. Continuous learning is also essential for personal and professional development. **Interviewer:** What role do relationships and networking play in your career, and how do you go about building and maintaining strong connections?

SM: Networking is crucial for career advancement. While having talent, intelligence, and expertise is important, it's equally important to be recognized for these qualities and be given opportunities to utilize them. Building a vast network is key, but it's not necessary for all connections to be strong. This would be unrealistic. For example, if you have 5000 LinkedIn connections, it's impossible to have a strong relationship with every one of them.

I once met someone from South Africa six years ago,


and we exchanged business cards. Every year, we wish each other a happy new year, but we don't have a close relationship. However, if I need a contact in South Africa for something minor, I can reach out to them. Similarly, they can also reach out to me for small favors that don't require a significant investment of time or resources.

Strong relationships are the ones that I will reach out to if I have a nephew and I need to get a job for that nephew. When it comes to securing a job for my nephew, I rely on strong relationships. Not everyone is willing or able

to help in this way, so it's crucial to cultivate such relationships. However, these types of relationships should be chosen like books - few but highly impactful. Just as you wouldn't read every book ever published, you shouldn't have too many friends, but rather select those who are beneficial and positively impact your life. Don't forget to strike the balance in terms of how often you keep up with them because familiarity breeds contempt.

For those who want to start building strong relationships, expect the worst, but hope for the best because people will fail you. Chances are you understand that not everyone is honest, not everyone is loving, and not everyone is loyal. Despite witnessing strong relationships in the past, I've also observed that unforeseen events can cause them to crumble, leaving former allies to become bitter enemies. The high number of divorce cases in our society is a testament to the fact that even seemingly strong relationships can come to an end.

Interviewer: Balancing work and personal life can be a challenge, especially in high-pressure leadership roles. How do you maintain a healthy work-life balance, and what strategies have worked well for you? How do you prioritize staying healthy and fit in your busy schedule, and what do you enjoy doing to stay active?



SM: We all tend to underestimate health as an important bedrock for everything. Sadguru highlighted the heart's significance by stating that "if this pump isn't pumping, then everything stops. It's essential to recognize that good health enables us to achieve our goals without experiencing downtime. Through personal experience and observation, I have learned that maintaining optimal health requires a combination of exercise and a healthy diet. Ignoring one while focusing solely on the other won't yield the desired results. Although exercise may seem daunting, pairing it with an activity that you

enjoy can make it less tedious. For instance, dancing, listening to music, meditating, or solving problems while exercising can make it more enjoyable. Golf is an excellent sport for honing problem-solving skills while staying active.

For me, I find it difficult driving out to the gym, so I stay active by meditation and problem solving. Driving to the gym is a deterrent because I must dress up, drive out, and park. If I had a gym at home, I would find it more convenient to exercise and shower immediately after finishing my workout. Many people who register with gyms seldom go, so having an accessible workout space at home could motivate me to maintain a consistent exercise routine.

Interviewer: What advice would you give to someone just starting out in their career, and what do you wish you had known when you were starting out?


SM: Firstly, I have no regrets. I recommend watching Carl Sagan's intriguing video, "The Pale Blue Dot," which can be easily found through a quick Google search. Concisely, nothing happens by accident. Although there are various aspects of life that we can control, there are also many occurrences beyond our influence that affect us, and we cannot deny their existence. For instance, we cannot choose our parents or our DNA, meaning that our very existence is not a conscious decision. Consequently, it is important to understand the boundary between what we control and what we do not.

Ultimately, seeking guidance is essential, whether actively or passively. Active guidance involves seeking out mentors, reading extensively, and learning from those who have accumulated life experiences. Conversely, passive guidance can be achieved through prayer and communication with a higher authority.

Secondly, if you have the option or luxury of choosing what to do, pick a job you are passionate about, rather than something to make a living. not just what to do to earn a living. Eventually, the income will come. Not only will this lessen your stress, but you may not even perceive it as work since you enjoy it and can engage in it at any given time.

Third reason, legacy is often overrated, and we shouldn't wait until we're wealthy to make a difference. Every day presents an opportunity to impact the world positively, and we shouldn't be concerned about leaving a legacy. Many people believe that making an impact is only possible when you have vast wealth, but that's a fallacy. The individuals who are remembered for their contributions to society are typically those who were social and engaged in meaningful activities. For example, while we don't know who built the Egyptian pyramids, we remember Socrates and other philosophers because they authored books and shared their wisdom with future generations.

Similarly, we may not know the richest person in India, but we remember Gandhi for his contributions to the country's independence movement. Bill Gates is an example of someone



who made a lot of money from technology but will likely be remembered for his philanthropic efforts. By tackling problems such as polio, energy, and education, he has made a significant impact on society. His promise to provide tablets and Wi-Fi to children worldwide, including those in remote areas, might end up becoming his most significant contribution.

While Gates may no longer be at the forefront of the technology space due to the emergence of younger entrepreneurs such as Elon Musk and Mark Zuckerberg, he will be remembered for his charitable work. In the end, it's not the wealth we amass that defines our legacy; it's the positive impact we have on the world.

2018 TO 2019

Payday Investor: Our Journey into the Fintech Space

In 2018, ARM made a groundbreaking move with the launch of Payday Investor – the first-ever fintech app developed by ARM for ARM. The launch was a momentous occasion and marked ARM's entry into the FinTech space. It was a bold step for us, transitioning from our traditional processes to standing head-to-head with the disruptive fintech players.

As Payday Investor began to meet the needs of investors, it quickly became a game-changer in the industry. In 2022, in response to ARM's brand unification process, Payday Investor merged into the ARM One app. This strategic move aligned perfectly with our new product goal of developing a single app for all ARM products and services.

Evolution in Application Eras: Deluxe & Navision

We have always been on a quest to find the best and most sustainable applications to support our business operations. We have gone through several eras, each with its own set of challenges and successes.

We started with Milesoft/Integra, which unfortunately wasn't as "soft" as we needed it to be to efficiently support our processes. After some trial and error, we found Navision, a stable and fantastic application that perfectly aligned with ARM's vision and is helping us achieve our goals seamlessly.

We also went through a series of transitions from Hi-Port to Fundware and finally to Deluxe, a renowned application that enables us to provide excellent services to our Deluxe/HNI clients. Our journey has been filled with challenges, but through it all, we have persevered, learned, and perfected our processes.

Super-fast redemption, account opening and subscription

Before the transformation, opening an investment account and processing funds would take at least a week. Can you imagine how much interest and opportunities were lost during this time? Not to mention the angry customers and social media trolls the Customer Experience team had to deal with.

But things have changed drastically. Thanks to the IT Transformation team's efforts, Aminat and her colleagues no longer have to process transactions manually. Now, electronic channels like E-bills, Interswitch, and direct integration to a Tier 1 bank (GTbank) have made the subscription process lightning fast. Redemption that previously took 3-5 days now takes 15 minutes to 3 hours! Account opening time has also been reduced from 2 days to just 3 hours.

And that's not all! The introduction of Navision in 2019 has made the End of Quarter (EOQ) dividend process a breeze. No more manual calculation or investing for clients.

As of 2019, ARM had made some progress in automating its processes. We had moved from manual to partially automated operations as an organization.



2020 TO 2021

Fast forward to 2020, and we had made even more significant strides in our automation journey. We replaced our previous payment processing channels, Interswitch and E-bills, with Monnify and Paystack. As a result, our clients were given virtual account numbers, which allowed for almost real-time processing of their subscription inflows.

By integrating with GTBank, all our clients and prospects can now make payments through the GT Collection channel using their unique identifiers. This has made both our customers and Aminat, the CX staff member responsible for processing subscriptions, Customers happy. very receive value almost instantly, and Aminat is able to process transactions more efficiently. It's a win-win situation for everyone involved.

Auto-Matching System

While we sorted subscriptions coming in via GTBank, processing inflows from other banks remained a nightmare. In 2021. after several campaigns to clients, ARM built an auto-matching system auto-matching (AMS) for transactions with a unique identifier to the client's account Navision requiring no in human intervention. Navision sure knew the vision and understood the assignment!

To further intensify our transformation efforts, ARM embarked on its Retail and Digital Strategy Program, which birthed the ARM One product. This happened right in the middle of the Pandemic because we are relentless and resilient even in the face of a global pandemic.

Thankfully, the semiautomation we have previously achieved cushioned the effect of the heavy reliance on digital servicing to a reasonable extent, as the business was able to manage customers via digital channels.

2022 AND BEYOND

ARM One MVP (Minimum Viable Product) was launched in 2022 and the product is being managed actively by the DFS Agile teams.

The transformation also introduced the Agile way of working to ARM – a process which has been productive to date.

Currently, there are three agile teams running projects across the Organisation: two agile teams managing the ARM One platform, and one managing a large-scale CRM implementation.

The CRM & New Sales App implementation

This is a clear example of the cultural transformational change ARM has gone through in the process – of transitioning from the Waterfall project management to Agile delivery models. After setting up the ARM One Teams, it was time to start cascading Agile to the larger Organisation in practical terms.

What better way than to use the CRM & New Sales App implementation project which requires a diverse set of users from several teams collaborating to achieve success. Before the Agile adoption, it would typically take months for users to see any of the product's features. Now, users see output every other week and releases are a lot shorter with better quality.

In addition to adopting agile, we also intentionally included change management as part of cultural transformation, which will now be actively incorporated into projects, going forward.

From being a "Traditional' Asset Management firm, our journey to becoming an innovative front runner through several digitization and innovation programs such as the Retail & Digital Strategy Execution, Deji Alli Young Talent Programme and the ARM Labs Lagos Techstars Accelerator Program has led to global recognition of our innovative contributions to the financial services ecosystem and won us the International Chamber of Commerce and Mind the Bridge Rising Stars award in 2022.

Interviewer: Tell us about the roles and responsibilities required to pull off such an event?

The Programme Coordinator supports the Manager in Programme managing the implementation of the project plan, schedule, budget, expenditure, status, progress reviews, resources, issues, risks, changes, and deliverables. They attend project meetings and coordinate the execution of action points from the meeting. They document and follow up on important actions and decisions from meetings and ensure that all documentation in respect to the Programme is adequately maintained and up to date.

Finally, the Programme Resources provide administrative support and carry out project-related

activities and tasks as required. They work under the supervision of the Programme Coordinator and overshow their activities.

Interviewer: So far, what has been the impact of DAAYTA on startups and our society at large?

Odunayo Olowe: One of the significant impacts of DAAYTA is the development of young entrepreneurs with potentials to shape the future of Nigeria. Through this initiative, many young people have been given a platform to display their innovative ideas and turn them into profitable businesses.

Another positive impact of DAAYTA is its ability to encourage young people to see problems that they can fix and impact people's lives and the communities that surround them. This mindset shift has inspired many young people to act and contribute to the growth and development of Nigeria.

EMERGING PROPERTY OWNERSHIP STRUCTURES ON THE NIGERIAN MIDDLE CLASS

The concept of the "middle class" has evolved over time. Historically, the term was used to describe individuals who could compete with nobility, but today it typically refers to those who fall between the working class and upper class. In Nigeria, the middle class, which makes up around 23% of the population, has been declining in recent years due to economic challenges, emigration, inequality, and limited opportunities. Despite these challenges, the middle class remains an important driver of economic growth, serving as a stable source of demand for goods, services, and financial products like mortgages.

In the current housing market, the middle class is primarily interested in affordable properties, with one-, two-, and three-bedroom apartments averaging N13million, N22million, and N30million, respectively. However, a housing deficit of 28 million units, an inflation rate of 21.82% as of February 2023, high mortgage interest rates between 24% and 28%, and difficulty accessing low-interest loans through the National Housing Fund (NHF) are making it increasingly difficult for the middle class to afford homeownership. As a result, there is a growing need for more scalable solutions that can provide access to a wider pool of people at lower entry costs.



Fortunately, technology is transforming the real estate sector in Nigeria, with the emergence of property search tools, property financing tools, rental marketplaces, and real estate crowdfunding platforms. In the last four years, investment flows into the Proptech space have more than tripled from US\$3.2 million in 2019 to US\$12.4 million by the end of 2022. Real estate developers are targeting the middle class with innovative solutions such as co-buying or shared ownership arrangements, rent-to-own schemes (such as Mixta Africa's DUO), long-term leasehold arrangements, and fractional ownership. These ownership structures can help ease the equity requirement strain on individuals and make real estate investments more accessible to a wider pool of people.

In summary, the middle class remains an important driver of economic growth in Nigeria, despite challenges such as a fragile economy, declining disposable income, and unaffordable mortgage products. Diversified real estate ownership structures can offer a win-win situation for both real estate developers and middle-income consumers. As technology continues to reshape the real estate sector, it is likely that we will see more innovative solutions emerge in the coming years to address the evolving needs and preferences of the middle class.
